









- 2007 intermediate body for REGIO




BIRDA provides specific services to the local public administration as well as to the private sector for the development of the Bucharest-Ilfov Region

#### **Urbanization data**


Total EU population: 507,4 mil. inhabitants

Total BI Region: 2.25 million inhabitans



### **Bucharest-Ilfov Region data**

- 139% GDP/capita in PPS of EU28
- 238% GDP of the Romanian national average
- 59.3% of the total national FDI
- 23% of the total national SMEs
- Less than 1% of the Romania surface, but more than 11% of the population
- Ranked 11<sup>th</sup> in the world (1<sup>st</sup> in the EU) on Tom Tom Traffic Index (congestion level 48%)



# Investment Priority 3.1 A: Supporting the Energy Efficiency of Residential Buildings

Value allocated for the Bucharest-Ilfov region: EUR 99.4 million

### Types of eligible works

- thermal rehabilitation of the envelope
- thermal rehabilitation of the heating system / hot water supply system
- installing alternative systems for producing renewable energy
- other activities that lead to energy efficiency

# Investment Priority 3.1 B: Supporting the Energy Efficiency of Public Buildings

Value allocated for the Bucharest-Ilfov region: EUR 45.5 million

### Types of eligible works

- thermal rehabilitation of the envelope
- thermal rehabilitation of the heating system / hot water supply system
- installing alternative systems for producing renewable energy
- rehabilitation / modernization of the buildings lighting installation
- other activities that lead to energy efficiency

# Investment Priority 3.1.C: Improving the Energy Efficiency in the Public Lighting Sector

Value allocated for the Bucharest-Ilfov region: EUR 5 million

### Type of eligible works

- replacing the filament public lighting systems with lamps having high energy efficiency;
- acquiring/installing telemanagement systems for public lighting;
- expanding the public lighting system to urban localities

# Priority Axis 3 - Investment Priority 3.2 Promoting the Sustainable Multimodal Mobility

Value allocated for the Bucharest-Ilfov Region: EUR 149,9 million

### Type of eligible works

- •Investments designed to improve the urban public transportation
- Investments designed for electric and non-motorized transportation
- •Other investments designed for reducing the CO<sub>2</sub> emissions in the urban areas

# Investment Priority 5.1: Preservation, Protection, Promotion and Development of the Natural and Cultural Heritage

Value allocated for the Bucharest-Ilfov region: EUR 26,5 million

### Type of eligible works

- restoration, protection, preservation and production of indoor paintings, frescoes, outdoor murals;
- installations, equipment and endowments necessary in order to meet the airconditioning, fire safety and anti-theft conditions);
- endowments to expose and protect the mobile and immobile cultural heritage;
- marketing and touristic promotion activities

Investment Priority 5.2: Implementing actions intended to improve the urban environment, revitalize cities, regenerate and decontaminate the brownfileds

Value allocated for the Bucharest-Ilfov region: EUR 14,1 million

### Type of eligible works

- increasing the surface of green areas
- functional reconversion and/or reutilization of certain lands and degradated or unutilized surfaces inside the cities, and transforming them in leisure and free time areas for the community
- developing pedestrian alleys, bicycle lanes, sidewalks;
- creating recreational facilities for the developed lands
- endowment with urban furniture (benches, trash cans, etc.);
- modernizing the urban streets neighboring

#### Why Bucharest needs special attention on urban regeneration

- During the communist period the Capital City was a magnet for industrial development and workforce
- Entire neighborhoods were built near industrial platforms:
  - 1960s 1800 blocks of flats
  - 1970s 3000 blocks of flats (65% more)
  - 1980s 2600 blocks of flats
  - 1990s <800 new blocks of flats</li>
- the population has doubled in five decades
- Today: 65% of the population
  (1,5 million) lives in apartments



### Importance of strategic planning

- An integrated approach regarding urban regeneration must be assumed as fundamental in most part of the policies for organization and planning of regions and cities
- Exemples of documents in BI Region, in which is reflected and prioritised the concept of Integrated Urban Regeneration in order to optimise, preserve or revalue the urban capital (social, built environment, heritage, etc.):
  - Bucharest-Ilfov Regional Development Plan 2014-2020
  - Sustainable Urban Mobility Plan for Bucharest-Ilfov 2016-2030
  - Cultural strategy for Bucharest 2016-2026
  - The future Smart City Strategy of Bucharest Capital City

### Bucharest-Ilfov Regional Development Plan 2014-2020 (I)

A strategic document that outlines the priorities for the Bucharest-Ilfov development region in terms of competitiveness, social cohesion and sustainable development

#### **Global Strategic Objectives:**

- √ Consolidating the regional competitiveness
- ✓ Reducing intraregional disparities
- ✓ Sustainable urban and rural development

# Regional Development Plan of Bucharest-Ilfov 2014-2020 (II)

#### >A document based on a consultation process

Some thematic working groups at BI regional level:

- Employment, social inclusion and social services;
- Competitiveness and energy efficiency;
- Rural development, agriculture, fishing;
- Education;
- Health services;

Stakeholders: the General Council of Bucharest, Ilfov County Council representatives, local authorities, Regional Directorate of statistics, agencies for employment, directions for culture, religious affairs and cultural heritage, the business community, trade unions, public health directions etc.
